The Venue

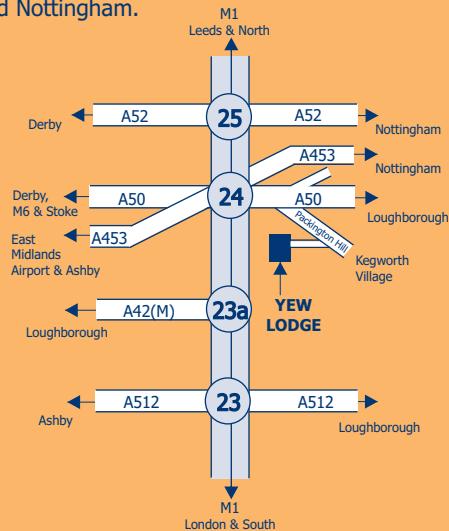
The Pest-Ventures seminars are held at the Best Western Premier Yew Lodge Hotel in modern conference facilities.
